Attachment 1

POLICY AMENDMENT PROPOSAL

Due to extenuating circumstances (weather, facility availability, referee/umpire availability, proms, graduations, etc.), the sport chair, in consultation with the executive committee, is authorized to reschedule contests to an earlier date than originally scheduled. All games within that specific classification and in the same respective round, should be offered the same opportunity.

Competing schools, by mutual agreement, may request the Sport Chair move a previously scheduled contest to an earlier date due to extenuating circumstances (weather, facility availability, referee/umpire availability, proms, graduations, etc.). Sport Chairs may only approve these request if the following criteria are met:

- All schools competing in that specific classification and in the same respective round are in agreement and afforded the same opportunity.
- Facilities and Referee / Umpires are available to accommodate the move.
- It is determined the move to an earlier date will benefit the tournament as a whole while still maintaining the overall integrity of the tournament.

Attachment 2

### **Stipend Updated Language**

The stipend includes compensation for any preparatory work related to organizing tournaments for the assigned sport and its championships. It does *not* include compensation for serving as a tournament director or for performing on-site duties during championship events.

**Executive Committee Meeting Stipend Eligibility** 

Individuals shall be eligible for stipend compensation for all meetings attended in the capacity of Sport Chair, on behalf of the Sport Chair, or at the request of either the Sport Chair or the District XI Chairman. This provision does **not** apply to District XI Executive Committee meetings, which are excluded from stipend eligibility.

### Attachment 3

### **Executive Committee Representation**

The Executive Committee shall include, whenever possible, at least one representative from each of the three leagues/conferences within District XI. This structure is intended to promote balanced representation and ensure that the interests of all member leagues are considered.

In the event that no viable candidate is available from a particular league or conference, this requirement may be waived at the discretion of the Committee in order to maintain effective leadership and operational continuity.
