SEEDING MEETING: Coaches will meet on Wednesday, February 11th, at 7PM. The meeting will take place via video

teleconference. This meeting is mandatory because we will be manually seeding the tournament. All Reps need to be School Hired and appointed coaches. All entries are final at the beginning of the meeting. Seeding will be finalized in this meeting. Brackets will be posted by noon on Friday, February 13th, 2026.

ALL Entries must be made on the OPC Site.

This information is tentative, and changes can be made up to the start of the seeding meeting. Once seeding is complete brackets will be re-seeded until the close of weigh-ins, at which point all removals of wrestlers will be forfeits.

NOTES:

- (a) A team forfeit (e.g., strike) does not count in an individual wrestler's record. An individual forfeit does count.
- (b) Certified weights on eligibility sheets must be for specific weight classes.
- (c) At minimum, top 4 wrestlers will be seeded in each weight class. The Tournament Director will determine how many wrestlers get seeded per weight. All others will be placed by random draw.
- (d) There is no such thing as a medical forfeit in high school wrestling. Any match that should have been contested has a result.

Number Advancing to Regionals

Three wrestlers will advance to the Regionals.

Reminder, Regionals will be eight wrestlers per weight class.
